Items Needing Approval	<p>Budget 2018-2019</p> <ol style="list-style-type: none"> Mary explained that there was a formula problem in some items calculating expenses so that the Budget presented at the BOD had some revisions - resulting in a budget that still showed a deficit but only \$33,646 However, we have sufficient funding to cover this in savings as last year we actually spent \$99,005 less than what we budgeted. We also had been holding back money from our original increase in membership dues (We made an \$8 increase to handle the \$2, annual increase from USA swimming over 10 years so we would not have to vote an increase each year . The excess in dues we took in from the beginning years was stored in savings to be put back in the budget for the last two years when our membership dues would be less than the increase).
